

# **NEWS REVIEW**

## **CREMATORIA NEWS**

**New Milton** Town Council's Planning Committee has agreed to recommend New Forest District Council approve the proposal to build a multi-million-pound crematorium on green belt in the New Forest. **Westerleigh Group** has applied for planning permission to construct a 130-seat facility on farmland off Stem Lane in New Milton, which will hold about 1,200 services a year. The Planning Committee voted unanimously to support the application, which is soon to be decided by New Forest District Council. For more on this development, please read the **Daily Echo article**.

More than £1.5m is set to be spent on overhauling **Whitley Bay Crematorium** after North Tyneside Council gave its approval to the upgrade. A report from the Council's Department of Environment Housing and Leisure said the two cremators at the crematorium are almost 20 years old and "approaching the end of their economic life". An extensive programme of works costing more than £1.5m is needed with two existing cremators being replaced with one larger 'mercury abatement' cremator. A new vehicle exit will be built in the cemetery to create a one-way system for traffic. For more on this story, please visit the **Chronicle Live website**.

A Government planning inspector has given the green light to a crematorium in Lach Dennis but says landscaping plans require a rethink. **The Birches Remembrance Park and Crematorium** was rejected by Cheshire West and Chester Council in 2012 but later approved on appeal. In 2016, a landscaping plan was approved – but the Council and residents say this and other approved aspects were not adhered to. However, Planning inspector Hilda Higenbottam concluded: "The building as built, and the car park layout are acceptable and should be approved. However, the changes to the levels, the hard and soft landscaping are unacceptable and so the relevant conditions remain unchanged."
