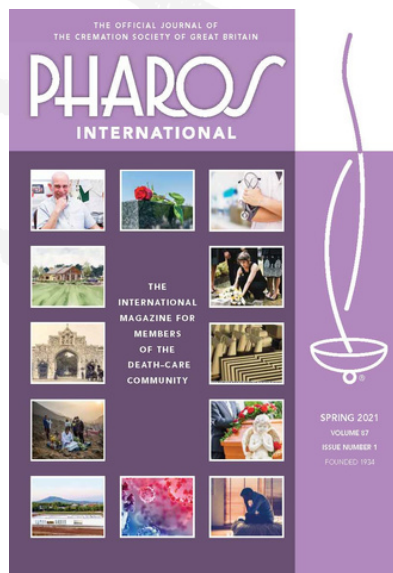

## NEWS REVIEW

### CREMATORIA NEWS

A government planning inspector has approved plans for a second crematorium to be built a mile from the site of its proposed **Sevenoaks** neighbour. **Bluebell Cemetery** in Badgers Mount was given the go-ahead after taking its application for extension of its chapel of rest, to appeal. In coming to her decision, planning inspector Rachael Pipkin said "it is not the role of the planning system to restrict competition between different commercial interests". A planning application for a new crematorium and memorial garden in **Woodhatch** has been submitted by **Reigate & Banstead Borough Council**. A pre-application consultation was held in the autumn for feedback on the plans. Over 300 responses were received, and over 130 people attended an online question and answer event with the design team. This resulted in some changes to the proposed scheme including reviewing the hours of operation, reducing the site boundary to maintain access for recreation, and changing the building layout and construction materials to soften its appearance. East Riding councillors have approved plans for a new £9 million crematorium in Preston. East Riding Council's planning committee approved local authority plans for the crematorium, off **Lelley Road**, by nine votes to two. Committee chair Cllr David Tucker said the application was always going to be a "contentious one". The committee heard from Council Project Development Manager Gail Cahill who said a number of changes had been made to the plans in light of concerns over traffic. She added council officers had spoken with funeral directors on helping them to plan routes that would avoid adding to congestion in the village. You can read more on the [Hull Live website](#).

### CREMATORIA NEWS

Caerphilly county borough's first crematorium has opened for use. Located in Pontllanfraith, it means residents of the borough can have a shorter journey than 30 minutes to reach a crematorium. **Sirhowy Valley Crematorium** is operated by **Westerleigh Group** who operate 35 sites across the UK. It joins three other sites in Wales to be run under the group. Kevin Davies, regional manager at Westerleigh Group, said: "We are delighted to have developed this new crematorium in Sirhowy Valley. We are pleased to be able to offer a facility that will significantly reduce this travel time, improving the experience for the bereaved and ensuring that their time can be fully focused on the funeral service itself." **Bradford Councillors** have voted to approve plans for a new crematorium in **Bierley** – despite an MP's calls for the decision to be deferred. But because the site, off Shetcliffe Lane, is on Green Belt, the Secretary of State could still halt the plans. The facility will replace Scholemoor Crematorium, which members were told was "past its sell by date." A report by planning officers had urged the committee to approve the plans. It said that despite the development being "inappropriate" due to it being in the Green Belt, officers felt it met the "extraordinary circumstances" needed to push a Green Belt development ahead. ### CREMATORIA NEWS

A new crematorium planned for **Heaton** has overcome its last hurdle after the Secretary of State declined to "call in" the plans. The facility at Long Lane will replace the existing Nab Wood Crematorium, and plans for the multi million pound facility were approved by **Bradford Council's** Regulatory and Appeals Committee last year. It has now emerged that Secretary of State has contacted the Council to inform them that he would not be calling in the decision. More money is needed to carry out plans to build a huge new crematorium in Nottinghamshire. In 2018, **Rushcliffe Borough Council's** cabinet approved the principle of a new crematorium in Stragglethorpe, near **Cotgrave** to better serve residents. Once complete, it is expected the crematorium could deal with 1,000 cremations a year. A sum of £6.5 million was included in the Council's capital programme to purchase the site opposite The Shepherd's Stonehouse pub and develop a crematorium. But following the appointment of design team, Ridge and Partners, the estimated cost plan was found to be greater than the budget previously agreed. A report has now been put together to outline the reasons why, the impact, and the request to approve a further £2 million. Families who have memorials at crematoria run by the **Westerleigh Group** are being offered an extra year free of charge. The goodwill gesture recognises the fact that restrictions placed on people because of the COVID-19 pandemic have meant people have been unable to visit the memorials to their loved ones for many months. Roger Mclaughlan, Chief Executive Officer of the Westerleigh Group, said: "Through providing an additional year to the length of existing memorial dedications at our crematorium, we are aiming to extend the precious opportunity of remembering a loved one." ### GOVERNMENT NEWS

The Department of Health & Social Care has issued updated 'guidance on the prioritisation of vaccination for 'funeral operatives', in line with advice from the Joint Committee on Vaccination and Immunisation. The guidance covers 'the driving of private ambulances; funeral direction; preparing the deceased and embalming in a hospital-based mortuary' as functions that represent potential exposure to COVID-19 infection. ### NATIONAL MEDICAL EXAMINER NEWS

Dr Alan Fletcher has issued an update on the national medical examiner scheme. It includes news of the 'Health and Care White Paper' which highlights plans to bring forward measures that contribute to improved quality and safety in the NHS, including the introduction of a statutory medical examiner system. It is anticipated that the non-statutory medical examiner system will continue throughout the 2021/22 financial year whilst parliamentary procedure is followed. #### National Medical Examiner update

Welcome

I am delighted the government published the White Paper earlier this month, including measures to put medical examiners on a statutory footing. The Royal College of Pathologists also shared their success with the 1000<sup>th</sup> medical examiner trained. You can read more about these important milestones below.

In my October 2020 bulletin, I mentioned my plan to publish a series of brief good practice papers for medical examiners, to support medical examiners and medical examiner officers in working more effectively with colleagues and partners. The Royal College of Pathologists recently published the first of these, which considers [how medical examiners can support people of Black, Asian and minority ethnic heritage and their relatives](#). I am very grateful to the college, and to Dr Habib Naqvi MBE, the Director of NHS Race and Health Observatory, who with other colleagues helped to shape this document. I plan to publish papers exploring other relevant issues in coming weeks and months.

We now have medical examiner offices in almost all acute trusts in England, and in all areas of Wales the medical examiner service continues to make excellent progress. I am delighted to welcome Rajiv Prinja to the national medical examiner team in the role of finance analyst for England. I am encouraged that despite pressures, the overwhelming majority of medical examiner offices in England have successfully submitted Q3 data. Together with information from the medical examiner service in Wales, this will provide more comprehensive information about medical examiner activity in both nations.

### APPG FOR FUNERALS AND BEREAVEMENT NEWS

### SECTOR NEWS

Autopsies determining a person's cause of death could take place digitally in Kent. **Kent County Council** (KCC), who run the local coroners service, seeks to invest £3 million into the creation of a 600 square metre digital autopsy facility in Aylesford. The site would be a base to carry out virtual post-mortems. On the virtual plans, a KCC spokesman said: "Kent's digital autopsy service will mean a significantly reduced number of invasive post mortems and quicker return of the deceased to their families for cremation or burial." The council is hoping to work with iGene to deliver the work, but no final decision will be made until a contract has been tendered. For more details, please read the [Kent Live article](#).
