## NEWS REVIEW

### CREMATORIA NEWS

Plans have been submitted by **Mercia Crematoria Developments**, for the new **Rushcliffe crematorium** to be built on land between Stragglethorpe Road and Main Road, near Cotgrave, Nottinghamshire.

The plans were submitted after a "public information day" in the area. A spokesman for Mercia Crematoria Developments, said "the vast majority of responses were very positive". More details can be found in the **Nottinghamshire Live article**.

Plans for a new crematorium in **Little Dunmow, Essex**, have been submitted by **Michael J Walsh Funeral Directors**. The family funeral directors have operated in the area for over 100 years. **Cannock Chase** Council's Planning Committee have unanimously voted in favour of plans for a new crematorium in Cannock Chase. The plans, submitted by **Horizon Cremation**, include a ceremony hall, memorial areas, garden of remembrance and parking facilities. Councillors agreed that whilst the site is located in the Green Belt, there were special circumstances for allowing the crematorium because there was a great need for it in the district. ## CREMATORIA NEWS

A planning application has been submitted by **Landlink Estates** for a new crematorium in Yapton, Arundel. The proposed **Central Arun Crematorium** is being put to Arun District Council and would include a single chapel seating up to 120 people and a separate family room. **Aberdeen crematorium** has reopened after a £1 million refurbishment. The refurbishment sees the crematorium with new entrance and reception areas, new flooring and seating in both chapels, new disabled toilets, new lighting, and a new digital media system. **Hinkley and Bosworth Borough Council** are set to approve plans to build and run a new £4.6 million crematorium near Hinckley's Leicester Road Stadium. If built, the crematorium will be the fifth crematorium situated in Leicestershire. For more details, please read the **Leicester Mercury article**.

**Havant Crematorium's** wildlife initiative has been hailed a success following its latest annual monitoring survey. The Oaks site includes ancient semi-natural woodland, designated as a Site of Importance for Nature Conservation, a natural pond and a wildflower meadow.

Gemma Lacey, Southern Co-op's director for sustainability and communications, said: 'As we celebrate The Oaks' fifth anniversary, we can also celebrate the success of being able to make a real improvement to biodiversity on the site.' ## FUNERAL DIRECTOR NEWS

MEPs have voted to restrict the use of formaldehyde, used widely in the embalming process. The industrial chemical is to be added to the European Commission's list of restricted carcinogens and mutagens.

West Midlands MEP, Anthea McIntyre, has secured a three-year delay in the implementation of the EU directive, to allow funeral firms to search for a feasible alternative. You can read the full **BBC News article here**.

## BEREAVEMENT SECTOR NEWS

**Bliss**, the UK charity for premature and sick babies, and **Sands**, the stillbirth and neonatal death charity, have revealed in a joint UK audit of neo-natal units, that bereavement care for parents whose babies die in the first few weeks and months of life is 'worryingly inconsistent and under-resourced'.

## NEWS FROM SCOTLAND

**Scottish Parliament** is now scrutinising the third set of the **Cremation (Scotland) Regulations 2019** which, if passed, will take effect from 4 April 2019. Once effected, this will include new cremation forms which will be available from the Scottish Government website and will be circulated to cremation authorities prior to the effective date that they are to be used from.

The Scottish Parliament will also consider the third set of the **Burial and Cremation (Scotland) Act 2016 Commencement Regulations** and **Pregnancy Loss Regulations** which, again, are expected to take effect from 4 April 2019. **The Scottish Government Inspection Regulation Working Group** also held its first meeting in December 2018. Among other subjects discussed, were the proposals surrounding future inspection of burial authorities, in addition to the existing inspection of cremation authorities and funeral directors already in place. More will be reported on this, as matters progress.

---

The **Scottish Government** has announced that a new benefit providing help for people on low incomes to meet the costs of a funeral is on course to be delivered through Social Security Scotland by summer 2019.

**Funeral Expense Assistance (FEA)** will replace the current DWP Funeral Payment in Scotland and improvements mean around 40% more people will be eligible to apply. FEA will provide financial support directly to those who need it most at the point of bereavement.

## NEWS FROM IRELAND

**Cork County Council** have requested further reports from Classic Lodges (Ireland) Ltd in relation to the application to build a crematorium on the site of the former Duhallow Park Hotel. The Council have requested information in relation to 13 key points, including access arrangements and air and noise assessments. The Council have stated that should Classic Lodges fail to supply all of the further information requested within six months of the request being issued 'the application shall be declared withdrawn'. ## INTERNATIONAL NEWS

Denmark has ambitiously aimed to be 'fossil free' by 2050. With 83% of deaths resulting in cremation in 2017, even one of Denmark's city crematoriums is taking steps to become carbon neutral. You can read more details on the **NDTV website**.

A mass marine funeral that went 'horribly wrong' resulted in three urns containing human ashes being washed up on beaches in the Netherlands. A Dutch shipping company, Trip Scheepvaart, admitted that the urns had slipped out of an employee's hands during the exercise and the urns were found by a schoolboy, a fisherman and a woman respectively on Katwijk and Noordwijk beaches north of The Hague. 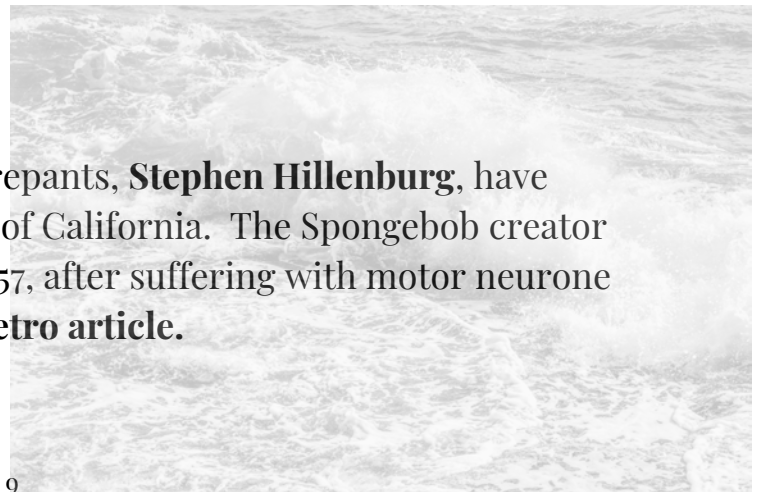
