# **NEWS REVIEW**

## **CREMATORIA NEWS**

A public hearing over whether to allow a new crematorium to be built between Shrewsbury and Oswestry opened on 11 March 2020. Westerleigh Group hopes to overturn a Shropshire Council planning committee decision to refuse permission for the facility to be constructed near Nesscliffe. The hearing is now currently on hold due to the coronavirus outbreak. You can read the opening news on the Oswestry and Border Counties Advertiser website and we will update on this news story as and when it progresses.

Plans to build a crematorium can now move forward after district councillors gave their approval. The unanimous backing of **New Forest District Council**'s planning committee means land east of Stem Lane and north of Great Woar Copse, **New Milton**, will be developed with a single chapel building, by the **Westerleigh Group**. The Planning Inspectorate has refused an appeal submitted by **Westerleigh Group** against a refusal of planning permission for a crematorium planned at **Garforth Golf Range**, Garforth, Leeds. You can find the full details on the <u>Planning Inspectorate's website</u>.

Groundworks have begun on a £4.9m crematorium to be built outside Hinckley. Malcolm Evans, estates and assets manager for Hinckley and Bosworth Borough Council, is managing the project. He said previously: "The project will deliver a modern, fit-for-purpose crematorium facility that meets the growing need for the population of Hinckley and Bosworth and surrounding areas." ## **CREMATORIA NEWS**

Plans to build a new crematorium in **Oxted** have been announced by **Horizon Cremation.** Director Stephen Byfield said, "If we get planning permission, we will be able to give people a far better service than they have at present. Horizon allows people one hour for a cremation service, significantly more than anywhere else locally and, of course, our facility will be brand new, carefully designed with plenty of parking and built in a lovely landscaped setting." A plan to undertake major improvements to Southend's crematorium have been given the green light by council leaders. The work that will include rebuilding the chimney, replacing three cremators, building a new multi-faith viewing room and making repairs is set to cost the council £2.7 million. More than a hundred people attended a public consultation event for **Hambleton** district's proposed new crematorium on land near Skipton on Swale. "The feedback was very positive. When completed, the new crematorium will offer state-of-the- art facilities combined with more traditional aspects." said leader of Hambleton District Council, Councillor Mark Robson. It is hoped that a planning application will be submitted in April with work to start in Autumn 2020 and open towards the end of 2021. ## **GOVERNMENT NEWS**

The Competition and Markets Authority has extended the statutory deadline for the funerals market investigation by 6 months and the revised reference period deadline will expire on 27 March 2021. The CMA updated their webpage on 25 March 2020 confirming: 'Although we continue to welcome submissions to our investigation, we do not currently intend to publish any additional documents, or to update the inquiry timetable, until the situation has become clearer.' A <u>Government Press release</u> on 6 March 2020 confirmed that parents grieving the tragic loss of a child have used a government fund to cover the costs of their burial or cremation more than 1,000 times since the scheme's inception last July. The <u>Children's Funeral Fund for England (CFF)</u> provides bereaved parents with valuable practical support at a very difficult time. The scheme aims to reduce the financial burden for families by reimbursing burial and cremation authorities, and funeral directors directly.

# **REPUBLIC OF IRELAND NEWS**

The company behind the proposed development of a crematorium in **Kanturk** has said that there would be no impact on air quality, the environment, or to public health, should the development go ahead. **Classic Lodges (Ireland) Ltd** has appealed the refusal of planning permission by Cork County Council to An Bord Pleanala. The planning appeals board will now rule on whether the development can proceed. You can read more on the **Echo Live website**.
