The Cremation Society

Plans for a multi-million pound crematorium near **Daviot** have been refused. Businessman Fraser Milne, who owns Inverurie Garden Centre, lodged plans for the facility with Aberdeenshire Council last year. The proposal had previously gone before councillors twice but had divided opinion. Members of the Formartine area committee recommended the plan be refused, while their counterparts in Garioch wanted to see the crematorium get the go-ahead. But as the committees were both at odds with what should happen, the application went to the infrastructure services committee for a final determination. However, infrastructure chairman councillor Alan Turner backed the planners' recommendations and was "content" to see the plan be approved. Waseley Hills Cemetery and Crematorium has received commendation following an inspection by the **Federation of Burial and Cremation Authorities (FBCA)**. The cemetery and crematorium was given a perfect score for administration, grounds and memorialisation, and service and staff. The crematorium compliance scheme scrutinised six key areas of service delivery, based on discussions and an examination of more than 80 points of interest. Federation inspector, Mr Connelly was impressed with the knowledge and dedication of the team members, noting their professionalism and care. He found the crematorium to be operating in accordance with the three key areas of compliance: the Cremation Regulations 2009, the Defra Process Guidance notes 5/12, and the Code of Cremation Practice. The steel frame for a new crematorium in Bradford has been completed, as work continues to upgrade the city's burial facilities. The new crematorium off **Shetcliffe Lane** in Bierley - to replace the existing facility at **Scholemoor** - is set to have two service halls, car parking, state-of-the-art cremators, office space and a waiting room. It is the last step in Bradford Council's bereavement services overhaul, first announced in 2016, after the refurbishment of Oakworth Crematorium and the new crematorium at Shay Grange. **Ashfield District Council** plans to contribute £2 million towards the refurbishment of **Mansfield Crematorium**. The project was discussed at a meeting of the council's cabinet on Monday, March 17th. The crematorium refurbishment will include the installation of electric cremators, solar panels, rainwater harvesting and heat recovery systems to support the council's commitments to decarbonisation. A total of £7.37 million will be invested into the project by local councils. Ashfield will cover its share through a loan and Joint Crematorium reserves. The crematorium currently operates two chapels, runs three gas-fuelled cremators and has a capacity of 5,088 cremations a year when fully operational. The crematorium generates about £400,000 a year in revenue from its services, and the funds are then put into services across Ashfield. Works are expected to begin in the next 12 months and the crematorium will remain fully operational while building work takes place. Documents state that the purpose of refurbishment is to be 'more aesthetically pleasing' as well as 'improved functionality, a more efficient operation and an enhanced range of offers for bereavement services that meet changing demands.' Services offered at Haycombe Crematorium in Bath are excellent, with one of the highest environmental scores seen nationally, a new report has found. An inspection of the crematorium earlier this year by an inspector from The Federation of Burial & Cremation Authorities (FBCA) found it complies with three key standards and provides an excellent service overall. The inspector looked at Haycombe's cremation and administration facilities and environmental credentials, to ensure that residents continue to receive high standards of service. Haycombe, which is run by Bath & North East Somerset Council, provides bereavement services to people of all faiths and beliefs, or none, and designs services that are accessible to everyone. The council recently made improvements to reduce carbon emissions and help tackle the climate emergency at Haycombe, including installing a filtration system to eliminate nitrogen oxide and increasing biodiversity with new woodland, wildflower meadows and a beehive. In 2023 the FBCA awarded Haycombe an Environmental Policy Statement for operating sustainable services. As part of its inspection feedback this year, the FBCA said: "It was noted by our CEO that the environmental score was one of the highest we have seen for some time, so well done to all on a great achievement." Lea Fields is incredibly proud to have been awarded the Gold Certification for Environmental Excellence by the Greener Globe Funeral Standard. The award recognises the crematorium's commitment to implementing green practices to ensure a sustainable cremation service. The crematorium had previously been awarded bronze in December last year, but a recent environment and sustainability audit scored them the 'highest score for a crematorium so far' as they were awarded gold-level status for sustainability. Greener Globe's external audit is a suitability assessment that highlights areas of excellence and identifies opportunities to go even further for the planet. Lea Fields Crematorium has adopted several practices to reduce its environmental footprint across its operations, waste disposal and supply chain. For example, flowers left after services are composted on site and used around the grounds and the facility uses energy efficient processes throughout the cremation process. Plans to build a new modern crematorium and natural burial ground in **Leeds** have been unveiled. Drawn up by **Westerleigh Group** the state-of-the-art crematorium, set within landscaped gardens of remembrance, would be located on a 20-acre site at **Oulton**, six miles south east of Leeds and five miles north of Wakefield. Proposals would see natural burial grounds, of wild meadow and woodland, offered in Leeds for the first time - this would involve single graves, the use of biodegradable coffins or shrouds, and no granite headstones. The newly unveiled plans come as cremations at Lawnswood Crematorium remain on hold almost four months after "structural problems" were found in the building. The purpose-built modern chapel building would contain seating for a minimum of 112 mourners, with overflow standing areas. Facilities would also offer 136 parking spaces, including disabled, electric vehicle and coach provision, plus an accessible space with mobility changing bed and toilet. Members of the **Deceased Management Advisory Group (DMAG)** met for an in-person meeting in Solihull last week to discuss the current activities of the Group and plans for progressing a number of issues facing the deathcare sector, including the ongoing delays to funerals following the introduction of the statutory medical examiner system; the current Government's resilience strategy and the inclusion of the deathcare sector in its resilience planning; the challenge of unclaimed ashes stored by funeral directors; and the need for publication of the revised Process Guidance notes for crematoria. DMAG continues to work with the APPG for Funerals and Bereavement to highlight the issues faced.



Across two days, attendees will hear from over 20 speakers, representing a diverse range of professional and disciplinary perspectives drawing from anthropology-sociology, theology, ceramic-pottery art, music, funeral directing, funeral celebrants, and palliative care, as well as more personal reflections on loss and grief. All talks, some longer and some shorter, are in a plenary context and not parallel sessions to provide everyone with a widely shared audience.

At 7pm on Wednesday evening, there will be a special public lecture - doctor and ceramicist discuss the concept of 'closure'. Dr Kathryn Mannix (well-known palliative care physician) and Dr Julian Stair OBE (one of the UK's leading ceramicists) will be in conversation with Professor Douglas Davies FBA, followed by a drinks reception with views overlooking the River Wear and Durham Cathedral.
