#### **CREMATORIA NEWS**

Westerleigh Group's new crematorium at Uttlesford was formally opened with a dedication service led by the Bishop of East Anglia, the Right Reverend Alan Hopes. Cam Valley Crematorium opened in January and has already held almost 500 services. The chapel seats 100 and is equipped with a digital media system. The service was attended by the deputy mayor of Saffron Walden, religious and civic leaders, as well as representatives from across the bereavement sector. **North Wiltshire Crematorium** near Royal Wootton Bassett has opened its doors for the first time, holding eight services on its first day. Westerleigh's new facility began operating on 8 October 2018. The plans submitted by Dignity UK were deferred for the first time in July and have now been deferred again pending the results of further traffic surveys. #### **CREMATION LAW**

A consultant has admitted to signing 'several hundred' cremation forms over a period of five years, whilst failing to examine the body. Brian Cheadle, 63, worked as a consultant in acute geriatric medicine at Stepping Hill Hospital in Stockport. He pleaded guilty to making a false representation with a view to procuring the burning of human remains between 2010 and 2015 contrary to the Cremation Act 1902.
