

# **NEWS REVIEW**

## **CREMATORIA NEWS**

**Rushcliffe Borough Council's** planning inspectorate has granted consent for plans for a new crematorium based at Stragglethorpe near **Cotgrave** despite concerns raised by locals. The planning committee had initially turned down proposals for the site in March 2019 but developers **Mercia Crematoria Developments** launched a successful appeal. **South Lincolnshire Estates** and **Lincolnshire Co-op** have lodged an appeal against **North Kesteven District Council's** decision to refuse planning permission for a new crematorium near Thurlby. The developers' appeal will now be heard by the government's planning inspectorate on 3 December. To read more on this development, please visit **The Lincolnite website**.

**Grimsby Crematorium** could see a new farewell chapel built as part of a new extension to the existing crematorium. Plans unveiled also include facilities for a pet crematorium. The plans follow recently submitted plans for an expansion to double the size of the existing car park. You can read more on the proposals on the **Grimsby Telegraph website**.

**Dewsbury Moor Crematorium** has reopened following extensive modernisation as part of a £3 million refurbishment of Kirklees crematoria. The improvements include the replacement of outdated cremator equipment, refurbishment of the chapel and improved services for bereaved families. ## **CREMATORIA NEWS**

Hambleton District Council have approved proposals to develop a new crematorium on land near Thirsk. Councillor Mark Robson said: "This project is a completely new direction for the Council but will be providing an essential service to the people of Hambleton who currently have to travel some miles out of the district, and often endure a considerable wait for appointments, before they can say goodbye to their loved ones." **Belfast City Council** is seeking a design team for a new £15 million crematorium at Roselawn Cemetery. The project, planned to complete in 2024, will deliver a 'modern, state-of-the-art' facility, capable of hosting 4,500 cremations a year. It will feature two 200-capacity chapels, a waiting area, coffee shop, staff accomodation, car parking and landscaping. For more details, please read the **Architects Journal article.** 

**Arun District Council** has refused plans submitted by Landlink Estates, for a crematorium at **Yapton**, on the grounds of road safety. The plans discussed at the committee meeting on 9 October had previously been deferred pending a road safety audit. The Council has previously rejected other plans for a second crematorium near Yapton, submitted by Southern Co-op. Please visit the **Bognor Regis Observer website** for more details.

**Yeovil Crematorium** will see a total of £750,000 spent in making it more environmentally friendly, after refurbishment work was approved by South Somerset District Council. A Council report stated: "The council is investing £750,000 in the Yeovil Crematorium to ensure compliance with environmental standards. The new cremators...are designed such that the emissions from mercury fillings will be captured by abatement plant, along with particulate and other emissions." ## **CREMATORIA NEWS**

A new crematorium planned for the north-east could ease round trips of up to 120 miles which mourners currently have to make for services. **Aberdeenshire Council** have previously approved plans to build a crematorium at the site in **Crimond** but the permission had lapsed. The applicant, **The Firm of N Cowie**, has now lodged new plans with a slightly different layout. The 6.8 hectare facility would include 180 parking spaces at the former airfield. **Darlington Borough Counci** is expected to approve a £5 million improvement package for Darlington Crematorium. A review of the facilities was started in 2010 when a feasibility study was carried out while the local authority has been working with Rose Project Management to deliver the scheme. The proposed improvements will be subject to planning permission. More details can be found on the **Northern Echo website**. (Update: the Council approved the improvement scheme in its meeting on 8 October).

**Sunderland City Council** is considering a £7.5 million scheme to build a new purpose-built crematorium on the site of the existing crematorium, along with extended car parking facilities. The scheme is part of the Council's £200 million 'spending blueprint'. Further details are expected but in the meantime, you can read the story on the **Sunderland Echo website**.

Plans have been submitted to **Eden District Council** for the conversion of a site of farmhouses, into a crematorium. Part of the surrounding land will be used for a burial ground and memorial garden. The plans to convert the site at Ash Hill Farm near Penrith, were submitted by Cumbrian funeral operator **Fishwicks**, You can read more on the **Place North West website**.



#### **GOVERNMENT NEWS**

The Notification of Death Regulations 2019 came into effect on 1 October 2019. The Ministry of Justice has published guidance to assist registered medical practitioners in meeting their duties under the new Regulations. You can find the guidance on the Gov.uk website.
