

### Guidance for funeral directors and crematoria managers

We regularly take queries from members of the funeral sector on cremation issues. We were recently asked whether a crematorium can accept **scanned** application forms from an applicant. Having confirmed the position with the Ministry of Justice, s4 of the **Cremation (England & Wales) (Amendment) Regulations 2017** amends s14 of the Cremation (England & Wales) Regulations 2008, **allowing application forms to be submitted in electronic form** provided that they include an electronic signature. More guidance on this is given in the **guidance notes on the Gov.uk website**.

## NEWS REVIEW

### CREMATORIA NEWS

Plans for a major modernisation and improvement scheme at **Distington Hall Crematorium** have been submitted to Copeland Council's Planning Panel. The project includes internal and external modifications to enhance the experience for visitors and improve operational areas for staff. Further to the planning application, a second cremator is also in the process of being installed at the crematorium to improve efficiency and environmental performance. 


## CREMATORIA NEWS


After a long planning battle, an inspector from the Government's Planning Inspectorate has held a hearing as part of the consideration of an appeal from developers **H2Land** to add a crematorium to the planned **Waseley Hills Cemetery site**, Rubery. ## GOVERNMENT NEWS

HM Treasury has announced new plans to regulate the **pre-paid funeral sector** for the first time to 'ensure the market is competitive and consumers, who are often old and vulnerable, understand what they are buying.' 
## NEWS FROM SCOTLAND

Councillors from **Melrose Community Council** have confirmed their position over the scattering of ashes at prominent landmarks in the region. Town Councillor David Parker said: "I don't think anyone properly objects to people scattering ashes. It's the non-scattered ones that are the issue." Relatives regularly leave ashes at memorials, beauty spots and monuments in the region but concerns had been raised over heavy clumps of ashes being left. ## SCOTTISH GOVERNMENT NEWS

The Scottish Government has published guidance for local authorities on burial ground maintenance. The guidance is intended to assist them to meet their obligations to inspect and make safe memorials and headstones in local authority burial grounds. This guidance was created in response to recommendations made in January 2018 following a Fatal Accident Inquiry (FAI) into the tragic death of 8 year old Ciaran Williamson in 2015. ## FUNERAL DIRECTOR NEWS

A new initiative by **The Funeral Celebrancy Council**, a collaborative organisation made up of representatives from across the funeral sector, has been launched at the National Funeral Exhibition this month. The **Funeral Celebrant Accord** defines the attributes and skills required of an excellent funeral celebrant and is intended to set the standards by which all celebrants offering funeral services should be measured. ## INTERNATIONAL NEWS

**Malta** has passed its first Cremation Bill, introduced by Labour MP Rosianne Cutajar, allowing cremation services to be offered in Malta for the first time. The new law will not only introduce a burial alternative but will also allow people the flexibility to decide what to do with the ashes. Each crematorium will have a mortuary, a viewing room, adequate facilities for the extraction of implants from the body, a cremation room and a storage room for remains. ## BEREAVEMENT NEWS

Researchers at Cambridge University's Faculty of Education have published a report, commissioned by bereavement charity **Winston's Wish**, on '**Consequences of childhood bereavement in the context of the British school system**'. Researchers also gathered the experiences of adults who lost parents and siblings as children, which are presented in a separate report, 'Voices of adults bereaved as children'. ## AND FINALLY...

The city of Taipei in Taiwan has developed the **world's tallest columbarium**. **True Dragon Tower**, a 20-storey columbarium houses the ashes of over 400,000 people. It is traditionally organised with niches for funeral urns to be stored for visitors to attend as one might visit a cemetery. A basic individual niche measures about 22 by 25 centimeters (9 by 10 inches) and starts at about NT\$200,000 (\$6,500). More elaborate niches can cost more than NT\$1 million at the top end (excluding the costs of other funereal procedures such as memorial services and burning offerings). Despite the cost of a stay, nearly 1/10th of the building is already occupied, according to the article in **Architect News**.
