


## NEWS REVIEW

### CREMATORIA NEWS

**Memoria Ltd** has submitted plans to build a £6 million crematorium on the outskirts of **Faversham**. Memoria wants to construct a new base on farmland off the Thanet Way at Staple Street, where it will conduct almost 1,000 services a year. Memoria stated: "The provision of a crematorium in the proposed location would provide both ease of access from the wider road network, reduce the long distances currently travelled by the surrounding population to existing crematoria, and be accessible by sustainable transport modes." A new crematorium could be built on farm land near **Caersws** after a pre-planning process was launched. **Powys Crematorium Limited** intends to apply for full planning permission for a new crematorium at **Ael Y Bryn** – and has embarked on a pre-planning consultation period. A design and access statement by agent Alan Southerby explains the proposal: "The design successfully blends the essential characteristics of the site with the state-of-the-art facility. Within this context, it can be seen how the proposed development will both maintain and enhance the existing characteristics of the locality, responding positively to its location and setting." **Westerleigh Group** has submitted a Proposal of Application Notice to **East Lothian Council** to build a crematorium on land just off the A1 at **Old Craighall**. The 12-acre site would include a chapel, parking and a landscaped garden of remembrance. It is expected to accommodate an average of five or six services a day. Roger McLaughlan, Chief Executive Officer of Westerleigh Group, said: "There is a pressing need for a crematorium in East Lothian; this area already has a large population base which is going to grow further in the coming years, with some significant new housing developments being planned." ### CREMATORIA NEWS

Plans for a new crematorium in **North Cornwall**, with views over the Atlantic Ocean and designs inspired by ancient burial mounds, have been unveiled. The **Atlantic View Crematorium and Memorial Garden** proposal is for a single storey building, surrounded by wildflower gardens, ponds and woodland, set into the landscape near **Bude**. Howard Smith of the **Atlantic View Crematorium Consortium**, said: "This crematorium would greatly reduce funeral journeys at a time of loss and grief and prevent people from having to travel long distances to say goodbye to their loved one, thereby reducing the emotional turmoil this creates". Councils in west Hertfordshire are set to consider the funding of a new £8 million crematorium in **Hemel Hempstead**. The proposed single-storey crematorium – with remembrance chapel and gardens – would sit within an 'extensive landscape' on land adjacent to the new cemetery in Bunkers Park. Plans for the new facility have already been submitted to **Dacorum Borough Council**, by the **West Herts Cematorium Joint Committee** – which is made-up of representatives from Watford, Three Rivers, St Albans, Hertsmere and Dacorum councils. Now each individual council is to be asked to underwrite a share of the £6 million loan that's required so the project could go ahead. ### CREMATORIA NEWS

Plans have been discussed to create a new **Melton** cemetery on land off Nottingham Road with the possibility of building a crematorium on the site as well. This is one of the two options put forward in a report addressing the need to provide more plots soon with the existing Thorpe Road graveyard nearing capacity. **Melton Borough Council** backed the findings of the study at a meeting, as a framework for further discussions on the issue, with a decision being needed on which site to pursue by next year. ### REPUBLIC OF IRELAND NEWS

An Bord Pleanála have given the go ahead for a new crematorium in **Dundalk**. In January Gerard Hughes was granted conditional planning permission by **Louth County Council** for what would be the town's first crematorium at **Dowdallshill** on the Racecourse Road. However, this was subsequently appealed to An Bord Pleanála by Fred O'Hagan and others. An Bord Pleanála have now decided to give the development the go ahead subject to revised conditions. ### SCOTTISH GOVERNMENT NEWS

Social Security Scotland has paid out £8.7 million to people who have lost a loved one, since it started making Funeral Support Payments last September. Eligible applicants currently receive an average of £1,761 to help with the costs of a burial or cremation and expenses such as travel and flowers. Social Security Secretary Shirley-Anne Somerville said: "Coping with the death of a loved one is one of the most difficult events any of us can face – it's even harder when there's extra stress trying to find the money to pay for a funeral. It's important that we support people at key times like this. We want to do what we can to stop those who are dealing with grief having to get into debt too." ### INTERNATIONAL NEWS

Hindus in Malta are urging the government to subsidise cremations abroad until a crematorium is available in Malta. Hindu statesman Rajan Zed, President of Universal Society of Hinduism, said in a statement: "Malta, not having a mechanism for the cremation of deceased Hindus, is forcing the community to bury their loved ones in contradiction of their long-held beliefs that burial hindered soul's journey". The Hindu community said cremation abroad comes to around €5,000, but added options can raise the cost. Many non-Hindus now also prefer cremation over burial. 
